Each and every illegal alien's very first step across our border is a violation of our federal immigration laws, making them foreign invaders. The only right these individuals have is to go home on their own or face incarceration, deportation, and at the very least, criminal prosecution to the fullest extent of the law.

Establishing a zero-tolerance policy against the estimated **13 million illegal aliens** and especially those employing them and any government entity that harbors them remain our foremost and most effective means to end the illegal alien invasion. The federal government has been AWOL for decades in fulfilling its Constitutional responsibilities to protect American lives, liberty and property. The burden to protect American citizens has been shifted to state and local governments, who are left with no choice but to take individual action to address this important issue.


In Pennsylvania, the estimated **140,000 illegal alien population** is costing taxpayers **\$1.4 billion** annually in healthcare, education, incarceration and other associated costs. The Impact of Illegal Crime:

According to the Federation for American Immigration Reform (FAIR), state and local governments spend over \$8 billion yearly for the administration of justice for illegal aliens. In Pennsylvania, taxpayers spend \$74 million yearly for costs associated to police, corrections and judicial expenses for illegal aliens.

The crimes highlighted in the brochure are just a few of the increasing amount of documented incidences of homicide, gang violence, human trafficking, terrorism and other associated crimes committed by illegal aliens who should not be on American soil to begin with.

READING: Wayne Williams, 51, an illegal alien from the British Virgin Islands, was sentenced to 5-10 years in state prison for pouring gasoline on his ex-girlfriend and setting her on fire back in 2005. He will be deported after he completes his sentence. [Source: Reading Eagle, January 12, 2010]

HELLERTOWN, NORTHAMPTON COUNTY: A woman from the Cayman Islands, living illegally in the United States, was arrested by ICE agents. She had previous convictions of Tampering with or Fabricating Physical Evidence, Robbery, Aggravated Assault with a Weapon, Parole Violation, and Criminal Attempt at Fraud. HANOVER, YORK COUNTY: Francisco Javier Santos, 18, an illegal alien from Mexico, was charged with vehicular homicide in connection with a car crash that killed two people. Police said his blood alcohol content was nearly three times the legal limit. [Source: The Record Herald, September 17, 2010]

LEWISBURG, UNION COUNTY: Sergio Gonzalez-Salinas, an illegal alien from Mexico, was charged with incident assault after sexually assaulting a local motel employee. Police went to a local job site to arrest Gonzalez-Salinas and also identified 11 other employees who were in the country illegally. [Source: The Daily Item, July 19, 2011]

National Security Begins At Home Legislation:

Confronting the illegal alien invasion head-on in the Keystone State involves shutting off the three main incentives that incentivize illegal aliens across America's borders: illegal jobs, illegal benefits and illegal citizenship.

SUPPORT OUR LAW ENFORCEMENT AND SAFE NEIGHBORHOODS ACT: Modeled after the Arizona immigration law, this legislation would provide state and local law enforcement with full authority to apprehend illegal aliens for deportation.

CORRECTING THE MISAPPLICATION OF THE 14TH AMENDMENT: This two-part legislative approach, a bill and a state compact, will eliminate the "anchor baby" status of children born in the United States to illegal alien parents. The bill clarifies the original intent of the phrase "subject to the jurisdiction thereof" and the state compact will allow for the designation of "natural born U.S. citizen" on a birth certificate.

REQUIRING MANDATORY EMPLOYER ENROLLMENT IN THE FEDERAL SOCIAL SECURITY E-VERIFY PROGRAM: This legislation would require all employers in the Commonwealth, including government bodies, to enroll in the federal government's free E-Verify program to confirm Social Security numbers of prospective employees.

OTHER LEGISLATION INCLUDED IN THE NSBAH PACKAGE:

- Empowers law enforcement officers, providing reasonable suspicion, to attempt to verify the immigration status of suspected illegal aliens
- Terminating the professional license of any employer that knowingly hires an illegal alien
- Maintaining criminal history records of previously detained illegal aliens
- Establishing legal and economic incentives against "sanctuary" cities
- Creating a third-degree felony offense for any person who intentionally engages in the smuggling of human beings for profit or other commercial purpose

MURRYSVILLE, WESTMORELAND COUNTY: Noe Tovar Baltazar, 24, an illegal alien from Mexico, was sentenced for an attempted robbery of a motor vehicle. He attempted to carjack a mother and her young daughter. He had two previous convictions in Georgia for drunk driving. [Source: Pittsburgh Tribune-Review, November 24, 2010]

PHILADELPHIA: Five Ukrainian brothers were charged with smuggling illegal aliens from their native Ukraine through Mexico and in to the United States illegally. [Source: Philadelphia Inquirer, June 30, 2010]

HAZLETON, LUZERNE COUNTY: Noel Cala-Leliebre, who Hazleton police confirmed was living in the United States illegally, was charged with numerous drug-related offenses when police discovered approximately 30 grams of raw, un-packaged heroin and 75 bags of packaged heroin in his home. [Source: Standard Speaker, November 26, 2010]

BENSALEM, BUCKS COUNTY: Ramon Ramirez, who was living in the United States illegally, was charged with sexual assault, simple assault and other related offenses when he attempted to attack a woman in a parking lot of a local department store. He was also wanted on a burglary warrant out of California and had an active administrative warrant for his removal from the country by ICE. [Source: The Trentonian, January 14, 2010]

PHILADELPHIA: Four illegal aliens were charged in a federal court with conspiracy to run a prostitution ring in South Philadelphia. The defendants operated brothels out of residential homes. [Source: ICE, News Release, January 13, 2010]

GREENE COUNTY: Victor Manuel Gonzalez Martinez, an illegal alien from Mexico, was indicted by a grand jury on charges of violating federal immigration laws. Gonzalez has previously been deported from the United States eight times. [Source: ICE, News Release, August 20, 2010]

NORRISTOWN, MONTGOMERY COUNTY: Genaro Duarte-Velasquez, an illegal alien from Mexico, was charged with illegally entering the United States at least 10 times. Duarte-Velasquez also used the aliases of "Genaro Duarte," "Jannt Asquos" and "Genaro Bautista". [Source: The Times Herald, April 1, 2011]

CANONSBURG, WASHINGTON COUNTY: Samuel Juarez Cruz, 25, an illegal alien from Mexico, pleaded guilty to third-degree murder and conspiracy in the stabbing death Jose Medina, 26, of Honduras. [Source: Observer-Reporter, October 22, 2010]
